**NOTICE OF PUBLIC HEARINGS ON PROPOSED 2022-23 BUDGET
 AND PROPOSED TAX RATES FOR CASTRO COUNTY**

In accordance with Local Government Code 111.007 a public hearing on Castro County's proposed budget for fiscal year 2022-2023 will be conducted on **Tuesday, September 13, 2022 at 6:00 p.m.** in the County Courtroom, Room 109, in the Castro County Courthouse, 100 E Bedford St, Dimmitt, TX. Any taxpayer of the county may attend and may participate in the hearing.

At the conclusion of the hearing, the Commissioners Court shall take action on the proposed budget and the proposed tax rate for 2022-2023. (Local Government Code 111.008)

A copy of the proposed budget is on file for public inspection in the office of the County/District Clerk, Room 101, Castro County Courthouse, Dimmitt, TX 79027.

The Fiscal Year 2022-23 Budget is based on a proposed tax rate of \$.566 per \$100 valuation. The Effective Tax Rate of \$.546 was posted to the Castro County website (www.co.castro.tx.us) by the Castro County Appraisal District. If approved, this proposed tax rate will raise \$566 in county property taxes on a home appraised at \$100,000. The Fiscal Year 2021-22 Budget was based on a tax rate of \$.599 per \$100 valuation.

After notice and hearing the following motion was offered by Commissioner

Michael Godoby and seconded by Commissioner *Ralph Brockman*

"I move that property taxes be adopted at a rate of \$0.566 in Operating and Maintenance and \$.00 in Interest and Sinking for a total tax rate for fiscal year 2022-2023 of \$0.566 per \$100.00 property valuation."

This budget will raise more revenue from property taxes than last year's budget by an amount of \$387,480, which is an 11.4554 percent increase from last year's budget. Property tax revenue increased due to higher property appraisal figures. Windfarm revenue will be received through the County's tax abatement agreement. Under the budget, the County will provide for the payment of debt service of \$768,575.00 for the fiscal year on its Certificates of Obligation, Series 2017 from the windfarm revenue received by the County through the County's tax abatement agreement (PILOT Payment In Lieu Of Taxes).

NOTE: WHILE PROPERTY VALUATIONS HAVE CHANGED, THIS TAX RATE IS NOT THE SAME AS THE EFFECTIVE TAX RATE AND IS BASED ON THE CURRENT VALUE OF PROPERTY.

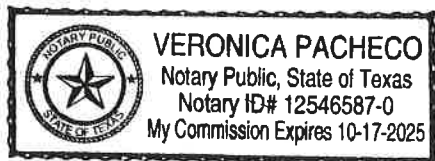
