**NOTICE OF PUBLIC HEARINGS ON PROPOSED 2015-16 BUDGET
AND PROPOSED TAX RATES FOR CASTRO COUNTY**

In accordance with Local Government Code 111.007 a public hearing for Castro County's proposed budget for fiscal year 2015-2016 will be conducted on **Wednesday, September 16, 2015 at 6:00 p.m.** in the Commissioners' Courtroom in the Castro County Courthouse, 100 E Bedford St, Dimmitt, TX. Any taxpayer of the county may attend and may participate in the hearing.

At the conclusion of the hearing, the Commissioners Court shall take action on the proposed budget and the proposed tax rate for 2015-2016. (Local Government Code 111.008)

A copy of the proposed budget is on file for public inspection in the office of the County/District Clerk, Room 101, Castro County Courthouse, Dimmitt, TX 79027.

The Fiscal Year 2015-16 Budget is based on a proposed tax rate of \$.561 per \$100 evaluation, which was published as the Effective Tax Rate on August 6, 2015. If approved, this tax rate will raise \$.561 in county property taxes on a home appraised at \$100,000. The Fiscal Year 2014-15 Budget was based on a tax rate of \$.542.

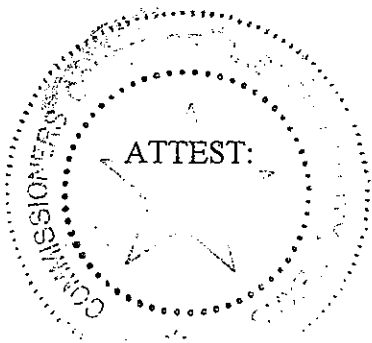

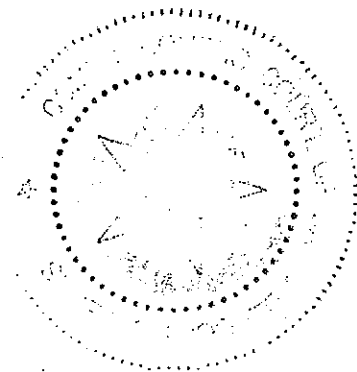

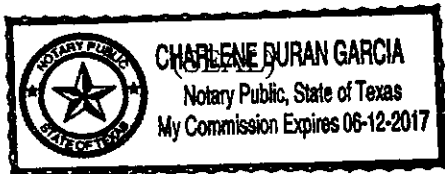

ORDER ADOPTING TAX RATE

After notice and hearing the following motion was offered by COMMISSIONER SMITH and seconded by COMMISSIONER BROCKMAN:

"I move that property taxes be adopted at a tax rate of \$0.561 in Operating and Maintenance and \$.00 in Interest and Sinking for a total Tax Rate for Fiscal Year 2015-16 of \$0.561 per \$100.00 property evaluation.

This budget will raise more property taxes than last year's budget by \$839,114. \$838,059 will be raised as a result of new property added to the tax roll for this year only and the associated windfarm property will be removed from the tax roll for the following 10 years in accordance with the county's tax abatement agreement.

NOTE: WHILE PROPERTY EVALUATIONS HAVE CHANGED, THIS TAX RATE IS THE SAME AS THE EFFECTIVE TAX RATE AND IS BASED ON THE CURRENT VALUE OF PROPERTY.
