**NOTICE OF PUBLIC HEARINGS ON PROPOSED 2018-19 BUDGET
AND PROPOSED TAX RATES FOR CASTRO COUNTY**

In accordance with Local Government Code 111.007 a public hearing for Castro County's proposed budget for fiscal year 2018-2019 will be conducted on **Monday, September 17, 2018 at 6:00** p.m. in the Commissioners' Courtroom in the Castro County Courthouse, 100 E Bedford St, Dimmitt, TX. Any taxpayer of the county may attend and may participate in the hearing.

At the conclusion of the hearing, the Commissioners Court shall take action on the proposed budget and the proposed tax rate for 2018-2019. (Local Government Code 111.008)

A copy of the proposed budget is on file for public inspection in the office of the County/District Clerk, Room 101, Castro County Courthouse, Dimmitt, TX 79027.

The Fiscal Year 2018-19 Budget is based on a proposed tax rate of \$.599 per \$100 valuation. The Effective Tax Rate of \$.581 was published on August 9, 2018 by the Castro County Appraisal District. If approved, this proposed tax rate will raise \$599 in county property taxes on a home appraised at \$100,000. The Fiscal Year 2017-18 Budget was based on a tax rate of \$.597 per \$100 valuation.

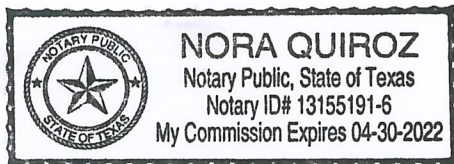

Godsby and seconded by Commissioner Elliott:

"I move that property taxes be adopted at a rate of \$0.599 in operating and Maintenance and \$.00 in Interest and Sinking for a total Tax Rate for Fiscal Year 2018-2019 of \$0.599 per \$100.00 property valuation.

This Budget will raise more property taxes than last year's budget by \$153,827.00.

Windfarm Revenue will be paid through the County's tax abatement agreement. Under the budget, the County will provide for the payment of Debt service of \$768,850.00 for the Fiscal Year on its Certificates of Obligation, Series 2017 from Reserved Revenue and the Windfarm Revenue received by the County through the County's tax abatement agreement (PILOT) Payment In Lieu Of Taxes.

NOTE: WHILE PROPERTY VALUATIONS HAVE CHANGED, THIS TAX RATE IS NOT THE SAME AS THE EFFECTIVE TAX RATE AND IS BASED ON THE CURRENT VALUE OF PROPERTY.
