**NOTICE OF PUBLIC HEARINGS ON PROPOSED 2014-15 BUDGET
AND PROPOSED TAX RATES FOR CASTRO COUNTY**

In accordance with Local Government Code 111.007 a public hearing for Castro County's proposed budget for fiscal year 2014-2015 will be conducted on **Tuesday, September 16, 2014 at 6:00 p.m.** in the Commissioners' Courtroom in the Castro County Courthouse, 100 E Bedford St, Dimmitt, TX. Any taxpayer of the county may attend and may participate in the hearing.

At the conclusion of the hearing, the Commissioners Court shall take action on the proposed budget and the proposed tax rate for 2014-2015. (Local Government Code 111.008)

A copy of the proposed budget is on file for public inspection in the office of the County/District Clerk, Room 101, Castro County Courthouse, Dimmitt, TX 79027.

The Fiscal Year 2014-15 Budget is based on a proposed tax rate of \$.542 per \$100 evaluation, which was published as the Effective Tax Rate on August 7, 2014. If approved, this tax rate will raise \$.542 in county property taxes on a home appraised at \$100,000. The Fiscal Year 2013-14 Budget was based on a tax rate of \$.573.
