A tax rate of \$ 0.597 per \$100 valuation has been proposed for adoption by the governing body of Castro County. This rate exceeds the lower of the effective or rollback tax rate, and state law requires that two public hearings be held by the governing body before adopting the proposed tax rate.

The governing body of Castro County proposes to use revenue attributable to the tax rate increase for the purpose of Courthouse--Jail Maintenance.

The effective tax rate is the total tax rate needed to raise the same amount of property tax revenue for Castro County from the same properties in both the FY 2016-2017 tax year and the FY 2017-2018 tax year.

The rollback tax rate is the highest tax rate that Castro County may adopt before voters are entitled to petition for an election to limit the rate that may be approved to the rollback rate.

YOUR TAXES OWED UNDER ANY OF THE ABOVE RATES CAN BE CALCULATED AS FOLLOWS:

In accordance with Local Government Code 111.007 a public hearing for Castro County's proposed budget for fiscal year 2017-2018 will be conducted on **Monday, September 18, 2017 at 6:00 p.m.** in the Commissioners' Courtroom in the Castro County Courthouse, 100 E Bedford St, Dimmitt, TX. Any taxpayer of the county may attend and may participate in the hearing.

At the conclusion of the hearing, the Commissioners Court shall take action on the proposed budget and the proposed tax rate for 2017-2018. (Local Government Code 111.008)

A copy of the proposed budget is on file for public inspection in the office of the County/District Clerk, Room 101, Castro County Courthouse, Dimmitt, TX 79027.

The Fiscal Year 2017-18 Budget is based on a proposed tax rate of \$.597 per \$100 valuation. The Effective Tax Rate of \$.587 was published on August 10, 2017 by the Castro County Appraisal District. If approved, this proposed tax rate will raise \$597 in county property taxes on a home appraised at \$100,000. The Fiscal Year 2016-17 Budget was based on a tax rate of \$.561 per \$100 valuation.
