Notice of 2020 Property Tax Rates in Castro County

This notice concerns 2020 property tax rates for Castro County, City of Dimmitt and Castro County Hospital District. It presents information about four tax rates. Last year's tax rate is the actual rate the taxing unit used to determine property taxes. This year's No-New-Revenue Tax Rate would impose the same total taxes as last year if you compare properties taxed in both years. This year's Voter-Approval Tax Rate is the highest tax rate the taxing unit can set before taxpayers can petition for a rollback election. Where applicable, this year's de minimus rate is the highest tax rate that taxing unit can set before a rollback election would be required. For taxing units that do not calculate a de minimus rate, a rollback election would be required if the proposed rate is higher than the Voter-Approval Tax Rate. The following rates are given per \$100 of property value.
