ORDER SETTING TAX RATE

On the 25th day of August 2025, at a duly posted and advertised public meeting on the Proposed 2026 Budget and 2026 Tax Rate, the following was transacted:

It is ORDERED on motion by Commissioner Ellis, seconded by Commissioner Coolsby, and carried with 4 members voting in favor, that the tax rate per \$100 valuation for tax year 2026 be set as follows:

Tax Rate	Purpose
\$0.43222	Ad Valorem Maintenance and Operation Ad Valorem Interest and Sinking (Debt Service)
\$0.09168	Farm-Market-Lateral Maintenance and Operation
Total Tax Rate: \$0.5239	

CASTRO COUNTY ADOPTED A TAX RATE THAT WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.

The tax rate will effectively be raised by **9.78 percent** and will raise taxes for maintenance and operations on a \$100,000 home by approximately **\$41.18**.
